### **4. Purposes and legal basis of the processing**

Your data will be collected to record you as the recipient of our newsletter.  
Your data will be processed on the basis of Article 6 (1) lit. a of the GDPR.

### **5. Recipients or categories of recipients of personal data**

Our service provider for managing the mailing list for sending the newsletter has access to the data.

### **6. Transfer of personal data to a third country**

It is not planned to transfer your personal data to a third country or an international organisation. The provision of your data takes place via a web application on the Internet. Therefore, the confidentiality, the integrity (inviolability), the authenticity (authenticity) and the availability of personal data cannot be guaranteed.

## **7. Duration of storage of personal data**

Your data will be stored after the collection for the duration of your subscription to the newsletter.

## **8. Rights of affected person**

Under the EU Data Protection Regulation, you have the following rights:

If your personal data are processed, you have the right to obtain information about the data stored about you (Article 15 GDPR).

If incorrect personal data are processed, you are entitled to a correction (Article 16 GDPR).

If the legal prerequisites exist, you can request the deletion or limitation of the processing and appeal against the processing (Articles 17, 18 and 21 GDPR).

In the event of a dispute, we will no longer be able to reach you as the subscriber of the newsletter, and we would delete you from the mailing list for the newsletter.

Since you have consented to data processing and data processing is carried out using automated procedures, you may be entitled to data portability (Article 20 GDPR).

If you make use of your rights mentioned above, the AHK will check whether the legal requirements for this have been met.
